Dutch fintech launches virtual private banker across Europe

The AI immediately structures this fragmented data into a single integrated overview.

The simultaneous launch across 17 countries is the first step in an ambitious global expansion strategy. Thomas Wealth aims to bring together technological innovation and financial expertise in a platform that is scalable worldwide. ROBUST SECURITY AND 'ZERO ACCESS'

Because Thomas Wealth operates in the financial sector, your privacy is central. Thomas Wealth applies a strict Zero Access policy: even company employees have no visibility into your financial positions. Your data is secured with AES-256 encryption, a standard used by governments and defence institutions, and all data analysed by the AI is fully anonymised first. Your personal data is never used to train AI models and is never sold under any circumstances.

24/7 INSIGHT FOR EVERY INVESTOR

Thomas Wealth puts an end to the idea that in-depth financial analysis is reserved for a small elite. The platform gives you 24/7 access to intelligent insights to better manage your wealth, including a real-time

overview of all your accounts and portfolios, insight into your tax positions across 17 European jurisdictions, and your virtual private banker: an intelligent interface that provides insight into financial scenarios around your life events and personal goals, via text, voice, and video.
